




Background: Revenues for Administration




Background: Revenues in Operations Budget




Background: Revenues in TDM Budget




Background: Revenues in STMP Budget

FY 23 Budget vs Year End Estimates






Changes in FY24 Operations Budget




FY24 STMP Budget



FY 23 Accomplishment Highlights


- Completed **San Pablo Avenue Multimodal Corridor Study – Phase 2** in partnership with the Alameda County Transportation Commission (ACTC) to investigate complete street elements.
- Launched the **Richmond Parkway Transportation Plan (RPTP)** effort based on a \$635,000 Caltrans Sustainable Transportation Planning grant



FY 23 Accomplishment Highlights

14

- Participated in the **I-80 Design Alternatives Assessment** led by MTC, with ACTC and CCTA. Previous WCCTAC studies helped shape outcomes
- Completed the Draft **West County Action Plan** for Routes of Regional Significance, which includes goals and actions for improving mobility.



FY 23 Accomplishment Highlights

15

- Created a new TDM program, **Take 10**, which provides 10 free trips on long distance bus routes for AC Transit, WestCAT and SolTrans.
- Had the largest year ever for the **Pass2Class Program**, with over 1,500 participants, which slightly exceeded pre-pandemic levels. The program offers free bus passes to students at the beginning of the year.



FY 23 Accomplishment Highlights

- Released a **Call for Projects** for \$5.3M in STMP funding for projects in West County.
- Revived the **Travel Training Program** which trains West County seniors on how to use local public transit and other services.
